### Terms of Payment

- 60% deposit invoice will be issued on receipt of Application Form and Contract.
- Final balance invoice will be issued November 2019
- All bookings received from November 2019 will be billed for 100% of fees.
- All invoices must be settled within 30 days, non-receipt of payments may result in release of reserved items

### Liability

The Organisers accept no responsibility for any damages if the sponsored event is not performed because of any obstacle or hindrance outside the control of the Organisers, which the Organisers could not reasonably have foreseen and which the Organiser could not have avoided at a reasonable effort or cost. ### Cancellation Policy
